

### COVID PROTOCOLS

ARTS for ALL Wisconsin is no longer requiring full vaccination, but still encourage staff and participants to get fully vaccinated and boosted and follow <u>CDC guidelines</u>. Masks are required at all indoor programs, classes, events, and exhibitions. Staff will wear masks during outdoor programming that involves sustained close contact. Individuals experiencing symptoms of sickness are asked to please avoid in-person activities.

#### **COVID-19 Policies and Protocols**

Due to the outbreak of the novel Coronavirus (COVID-19), ARTS for ALL Wisconsin (AFA) is taking extra precautions with the care of every staff member, participant, and guest to include health history review and enhanced sanitation and disinfection procedures. We strongly encourage vaccinations against COVID-19 and are happy to help individuals secure appointments.

It is our expectation that all staff, volunteers, and participants agree to the following by participating in in-person, indoor/outdoor programming, events, and performances.

- Staff, participants, volunteers, and guests will wear a well-fitting mask during in-person indoor programming, including events and performances. Staff members are required to wear masks during outdoor programming if contact with others is direct and/or sustained. Further, staff and volunteers are required to wear a well-fitting, air filtering mask such as a N95 or KN95 respirator which are provided by AFA. *Exceptions include:* Individuals with medical conditions, intellectual or developmental disabilities, mental health conditions, or other sensory sensitivities that prevent the individual from wearing a face covering; When communicating with an individual who is deaf or hard of hearing and communication cannot be achieved through other means: While a single individual is giving an educational, artistic, cultural, musical, or theatrical presentation for an audience, the single speaker or performers may remove the face covering when actively speaking or performing. While the face covering is removed, the speaker or performer should remain at least 6 feet away from all other individuals.
- Individuals experiencing any of the following will refrain from participation of AFA's in-person indoor/outdoor activities:
  - If you have been diagnosed with COVID-19 WITHIN THE PAST 7 DAYS, please follow the guidelines found here: <u>https://www.cdc.gov/coronavirus/2019-ncov/your-health/quarantine-isolation.html</u>
  - $\,\circ\,\,$  If household members are diagnosed with COVID-19 WITHIN THE PAST 7 DAYS
  - If you or household members have knowingly been exposed to anyone diagnosed with COVID-19 WITHIN THE PAST 7 DAYS
  - o If you have any symptoms of COVID-19. Please note that symptoms include:

### ARTS for ALL Wisconsin will to the greatest extent possible:

- Continue to facilitate remote work and other measures that limit the number of individuals present at the Art Center.
- Continue to offer online or virtual options for programming, performances, and meetings with artists, customers, participants, collaborators, and professional peers.
- Facilitate purchases and payments made in advance online or by phone, offer curbside pick-up, curbside drop-off, and delivery of goods and services.
- Implement shopping and gallery visits by appointment.
- Ensure that seating, art and music making stations, and performance areas are spaced to accommodate at least six (6) feet of physical distance between individuals not within the same household or living unit.
- Develop and implement a written hygiene policy and procedure that includes:
  - Ensuring employees and participants who have a fever or other symptoms of COVID-19 will not be allowed to work or participate.
  - Establishing hand-washing expectations and ensuring supplies are available.
  - Description of proper cough and sneeze etiquette.
- Develop and implement a written protective measure policy and procedure that includes:
  Ensuring individuals are at least six (6) feet from others whenever possible.
- Ensuring employees and participants are always provided with and wear face coverings when required.
- Develop and implement a cleaning policy and procedure that includes:
  - Guidelines for cleaning and disinfecting frequently touched surfaces
  - Guidelines for frequently wiping down any shared equipment, such as workspaces, computer stations, credit card machines, materials, carts, and baskets.
  - Protocols for cleaning/disinfecting in the event of a positive COVID-19 case on site
